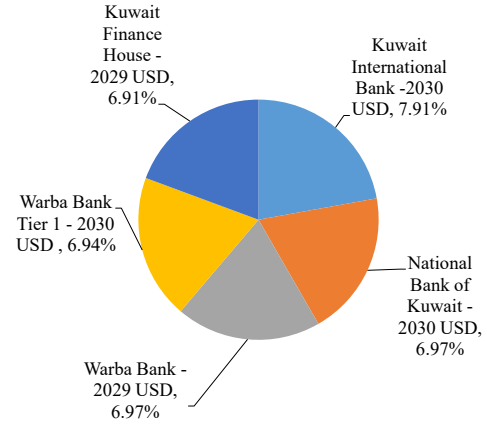


Fund Objective:-
